The European Union (EU) and the Community of Latin American and Caribbean States (CELAC) are currently preparing for the Summit of their respective political leaders to be held on 17-18 July in Brussels. At a time when our regions face serious security, socio-economic and ecological challenges, Bishops, Church communities as well as humanitarian and development organisations from Latin America, the Caribbean and Europe have recently expressed their hope that the renewed EU-LAC cooperation may focus on tackling the structural causes that undermine peace, social justice and societal cohesion. Based on their daily experience of accompaniment of people experiencing situations of vulnerability, they propose to orient the future EU-CELAC partnership around three pillars: (1) Integral human development & social justice; (2) Integral ecology & care for our common home; (3) Peace & a culture of encounter.

During this panel discussion, we hope to foster constructive discussions on concrete initiatives that can help put this vision into action, towards corporate accountability, fair trade rules, production and business models that protect human rights and the environment, just global financial and debt architecture, and democratic ownership of policyand decision-making processes.
