# CONCEPT NOTE

The designation of 2023 as European Year of Skills aims to address the current situation of the EU labour market, responding to the shortage of skilled labour across Europe. The European Commission's initiative, however, is inscribed against the backdrop of the harsh demographic crisis, manifold educational challenges and migratory issues, which permeate the context of skills provision in the EU. The main goal of the activities planned within this initiative's framework is to promote citizens' active involvement in the European internal labour market processes, provide upskilling and reskilling for all and increase employability and competitiveness.

In the 21st century, the era of the digital and green twin transitions, where the Covid-19 pandemic has accelerated digitalisation and the climate crisis calls for more **expertise in the areas of sustainability and ecology**, the **demand for technical skills** has increased dramatically in almost all directions, caused by new challenges in both the private and public sectors.

Undeniably, within the framework of the European Year of Skills 2023, the EU has tried to address the main challenges, but there are equally relevant topics that allow to understand skills provision more holistically and enlarge the main focus of policies and strategies. By looking deeper into these areas, it is possible to realise that skills are to be understood far beyond competitiveness and employability, reflecting on the need to be more practical and critical and considerings ecological skills, the inclusiveness and responsibility of digital spaces, as well as informal skills learnt in the family and the role of vocational training in tackling social exclusion as part of the equation.
